## TERMINATION OF DECLARANT RIGHTS

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- Termination of Declarant Rights. Effective as of the date hereof, Declarant hereby voluntarily relinquishes and terminates any and all of its rights, duties, and obligations as Declarant under the Declaration ("Declarant Rights").

- Resignation of Directors. Subject to the election of no less than three (3) individuals at the 24, 2025, Annual/Transitional Meeting, the resignations of Al Burtin,

and Clut Bob, Toylor Hackers, bory Hackers L., as officers and directors of the Association, will be accepted and effective immediately.

- 6. <u>Right to Annex</u>. Declarant, in conjunction with this Termination, waives, disclaims, and relinquishes any and all of its rights to annex additional property pursuant to Article 12, Section 12.3 of the Declaration.
- 7. All defined terms not defined herein shall have the meaning defined and set forth in the Declaration
